#### TERMS AND CONDITIONS OF TRADE FOR CUSTOMERS

These terms apply whenever Marlborough Classic & Custom Restoration Ltd provides a service of any kind to customers.

### **Payment**

Unless otherwise agreed in writing, payment is due on the completion of the work.

If agreed by management payment in full is due 7 days following the date at the top of the invoice

### **Default in payment**

If payment is not received by the due date Marlborough Classic & Custom Restoration Ltd reserve the right to charge interest at the current bank overdraft rate which will be added to all outstanding balances monthly until account has been paid in full. If still not received a final letter for payment will be sent. Then the account will be referred for collection and any reasonable cost will be added to cover collection fees.

### **Quotations**

All quotations for work are based on time and materials. A quote will be then written out which will be valid for a period of 30 days.

Often quotes can only be done as a visual. If however more work is found after disassembly the customer is informed and the quote will be adjusted accordingly.

## Estimates

Estimates are based on what can be seen from looking around the vehicle at the time. It may change when we start the disassembly process. We reserve the right to review our estimate. However we will inform the customer in writing before we proceed. If the customer disagrees to us continuing we reserve the right to be paid for work already carried out on the vehicle plus storage if any.

# Claims

All work done by us is guaranteed for a period of 6 months after completion. Parts purchased will not be guaranteed if defective.

No claim will be available under this warranty unless a written notice of this claim is received by Marlborough Classic & Custom Restoration Ltd as soon as reasonably possible after the defect is discovered. If it is found that the defect has been caused or aggravated by someone else then the contract becomes null and void. It is a condition of this warranty that if Marlborough Classic & Custom Restoration Ltd are required to repair any defects, such work will be carried out at such a place Marlborough Classic & Custom Restoration Ltd specifies and the customer is responsible for the defective work being bought to the said premises.

If the vehicle has been tampered with by a third party then our warranty will become null and void.

We reserve the right to hold the vehicle until the account has been settled in a satisfactory manner. A storage fee will be charged to each vehicle stored on our premises.
